

## Cotton On Kids Flashback Instagram Giveaway

### Terms and Conditions

1. The promoter of this promotion is Cotton On Australia Pty Ltd (“the Promoter”) (ACN 634 090 083) of 14 Shepherd Court, North Geelong, Victoria 3215.
2. Submissions are free and open to open to residents in Australia, New Zealand & South Africa aged 18 years and over. Employees of the Promoter and their immediate families and the suppliers and agencies associated with this competition are ineligible to enter.
